

Information about the processing of personal data

For filling system: Filling system- record keeping of the persons accommodated

Information about the processing of data subject's personal data under Paragraph 19 and Paragraph 20 of the Act No. 18/2018 Coll. on Personal Data Protection and on the amendment of certain other Acts (hereinafter referred to as the "Act") and Article 13 and 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as the "Regulation")

This information aims to provide knowledge about what personal data we process, how we deal with it, for which purposes we use it, to whom we can provide it, where you can obtain information about your personal data and enforce your rights in the processing of personal data.

1. Purpose of personal data processing and legal basis for processing

The purpose of the personal data processing is: keeping the records of the persons accommodated.

Personal data are processed pursuant to:

- Paragraph 13 point 1 (b) of the Act No. 18/2018 Coll. on Personal Data Protection and on the amendment of certain other Acts,
- Paragraph 24 of the Act No. 253/1998 Coll.
- Paragraph 5 of the Act. 48/2002 Coll.
- General binding regulation No. VZN_4_2020 on local taxes and local fees for municipal waste and small construction waste of the municipality Východná.

The legitimate interest of the Controller or third party

The processing of personal data for a purpose of the legitimate interests of the Controller or third party does not apply.

2. Identification of processed personal data of the data subjects

Data subjects, whose personal data are processed are: persons accommodated.

The extent of processed personal data of citizens of the Slovak Republic: name, surname, permanent address, ID number or travel document (passport) number, date of arrival and departure.

The extent of processed personal data of citizens of other countries: name, surname, permanent address, purpose of stay, ID or passport number, date and place of birth, nationality, visa number and expiration date, place of issuance or number of the residence document issued by the Slovak Republic or a member state and its validity, address of residence in the Slovak Republic, name of the host, and names and surnames of accompanying children, date of arrival, and departure.

3. Identification of recipients, categories of recipients

The Controller may provide personal data to the authorized entities, such as institutions and organizations, under a specific legal regulation or to the contractors (especially the data Processors) who have undertaken to accept reasonable safeguards for the protection of the processed personal data, as follows:

Personal data may be provided to other recipients if the data subject consents or orders to provide his/her personal data to them.

4. Transfer of personal data to third country/ international organization

Transfer of personal data to third countries or international organizations is not carried out.

5. Identification of the source of which the data were collected

Directly from the data subject, or his / her legal representative (in person, by email, phone call, through the Controller's website).

6. The retention period of personal data

The Controller shall process the personal data for the period necessary to fulfill the purpose, but for a maximum period of 1 year from the end of the calendar year in which the processing purpose was completed.

7. Profiling

The Controller does not process the personal data by profiling, or by other similar means based on automated individual decision-making.

8. Rights of the data subject

The data subject shall have the right to request from the Controller the access to processed personal data concerning him/her, the right to rectification of personal data, the right to personal data erasure or restriction, the right to object to the processing of personal data, the right not to be subject to a decision based solely on automated processing, including profiling, the right to data portability as well as the right to initiate the proceeding to supervisory authority. When the Controller processes the personal

data based on data subject's consent, the data subject shall have the right to withdraw his or her consent to processing at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. 9. Obligation to provide personal data

The provision of personal data is a legal requirement/ contractual requirement, or the requirement that is needed in order to conclude the contract. The data subject has the obligation to provide personal data and, if he/ she refuses to do so, the service can not be provided to him /her.
